VI. <u>COURSE INTRODUCTION</u>: Introduction to Constitutional Law explores the three branches of the government of the United States of America in relation to the context and purpose of the United States Constitution. The course will examine the separation of powers among the three branches of government, judicial review, the relationship of power between the federal government and the sovereign states. We will also review individual rights and specifically examine the bill of rights and other amendments to the United States Constitution. Additionally, we will look at strategies to assimilate constitutional law into critical thinking practices.

### VII. REQUIREMENTS:

- 1. While I do not prohibit the use of laptops during class, I encourage you to refrain from using them as it will help you develop significant skills in deep focus of complex legal issues. And it will develop your ability to take time-constrained handwritten notes (which is generally all you are allowed at oral argument in Court).
- 2. All cell phones must be turned off during class (not merely placed on vibrate or silent). As in all Courts you should practice self-prohibition of cell phone use to avoid unnecessary distractions during class.
- 3. You are expected to be fully prepared to discuss the issues presented in each assignment prior to the day of class. While some legal issues will take more than one class to complete you should have the full legal topic prepared for discussion on the first class day of that legal topic.
- 4. Regular participation, preparation, and attendance are expected.
- 5. There will be one or more multiple choice interim tests lasting no more than 15 minutes each. These tests will be graded in class with a following discussion of strategies for understanding constitutional law legal issues in the context of this kind of testing environment.
- 6. The final exam will be a 24-hour take home exam.
- VII. GRADE COMPOSITION: Your final grade will be determined by the multiple choice test(s) and the final exam. I will also consider, however, the development of your critical thinking skills as evidenced by your class preparation, participation, and attendance. The cumulative effect of these factors may result in my making a special mention in your evaluation. The majority of your grade, however, will be your performance on the required final examination.
- IX. ATTENDANCE POLICY: It is mandatory that students attend class sessions. While I understand public transportation can be unpredictable, please respect your fellow classmates and be in class <u>on time</u>. Repeated class absence or tardiness will be reflected in your overall class evaluation.
